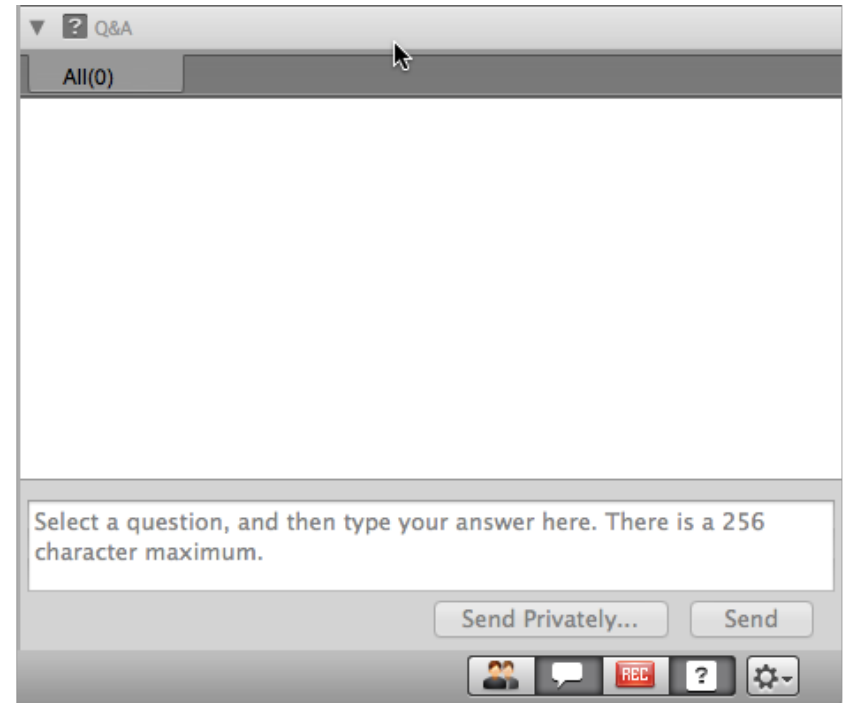

Welcome

General Observations

- Nurses are doing remarkable work across the country.
- Diverse pool of applicants: from community health clinics to major health systems; from Hawaii to Maine.
- Highly competitive: Out of 258 applications less than 10% selected as finalists.
- Proposals that most closely adhered to the Evaluation Criteria fared best.

Proposal Evaluation Criteria

- Health Impact
- Boldness and Creativity
- Technical Merit/Execution Plan
- Leadership
- Institutional Support
- Scalability
- Sustainability

A Word About Process

- 3 reviewers: Ahrin Mishan, Judith Woodruff, Linda Le.
- Rigorous review process: Each application read through at least twice. Top 25% were read and reviewed an additional 3 to 5 times and scored relative to RFP Evaluation Criteria.
- While the Evaluation Criteria was our primary-guide, instinct, experience and gut-response inevitably played a role. The process, in the end, is a subjective one.

Common Strengths

Common Strengths among proposals that made it through to the second round:

- *Nursing-Driven* not just *Nurse-Delivered*
 - Nurse-Delivered = Nurses are the designated workforce delivering the model.
 - Nursing-Driven = The model is rooted in nursing's strengths and holistic approach care
- Probability of Broader Impact
 - On health of vulnerable populations
 - On a specific field
 - On healthcare
 - On society

Common Strengths (continued)

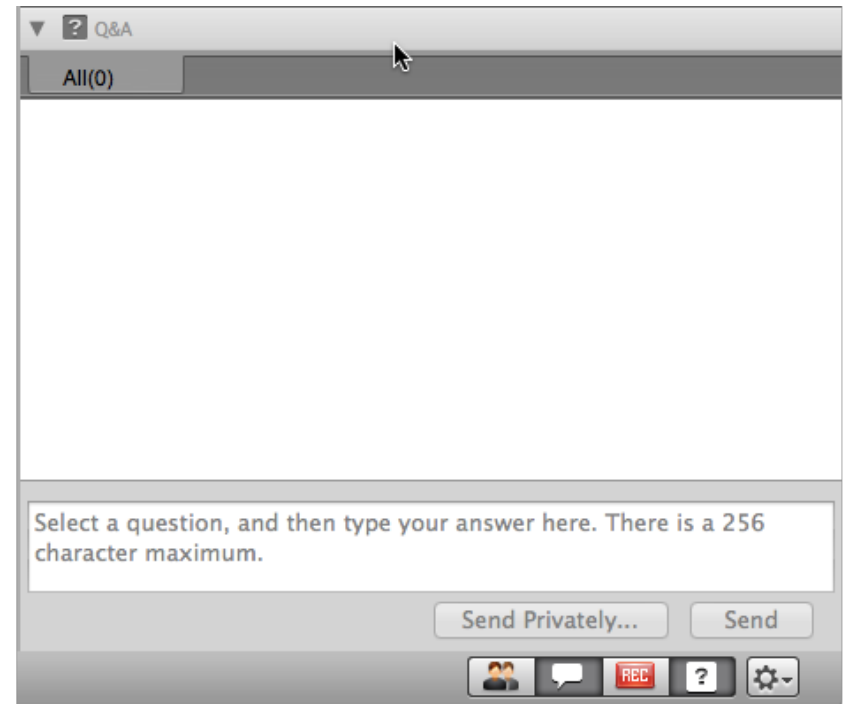
- **Scalability**
 - Potential for innovation to be replicated/scaled-up/spread on a large scale
 - Multiple determining factors:
 - Simplicity of model (not too many moving parts)
 - Strong cross-sector partnerships
 - Institutional influence and support
 - Feasibility
- **Boldness, Creativity, Innovation**
 - Creative solutions that address significant health and health-care problems in a new way
 - Potential for leapfrogging conventional approaches
- **Evidence**
 - At least enough evidence to suggest a likelihood for achieving positive outcomes on a broad scale.
